MOTION TO LIFT SUSPENSION

- 1. Rober Sweiss ("Respondent") is a nonresident insurance producer holding license number 424040 since August 2, 2002, to August 31, 2012, when Respondent's license expired and again when Respondent reactivated the license on May 16, 2016;
- On April 4, 2024, the Commissioner of the Indiana Department of Insurance ("Commissioner") verified through the Producer Database maintained by the NAIC that Respondent's producer license in Respondent's home state of Illinois was suspended on March 25, 2024;
- 3. Pursuant to Indiana Code § 27-1-15.6-8(g), on April 9, 2024, the Commissioner issued a Suspension Order suspending Respondent's license number 424040 until such time as the Commissioner received notification that Respondent's home state license is in effect; and

4. On May 24, 2024, the Department verified thought the Producer Database maintained by the NAIC that Respondent's producer's license in Respondent's home state of Illinois is in effect.
