FINDINGS OF FACT AND SUSPENSION ORDER

WHEREAS, Michael David Schlichte ("Respondent") is a nonresident insurance producer holding license number 3092109 since August 3, 2015;

WHEREAS, Indiana Code § 27-1-15.6-12(g) states, in part, that a licensed producer shall furnish the Commissioner with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding the request within ten (10) days of receiving a request;

WHEREAS, on November 3, 2023, the Commissioner sent certified mail # 7004 1160 0000 3835 6080 to Respondent's address of record requesting a list of appointments;

WHEREAS, on November 7, 2023, certified mail article # 7004 1160 0000 3835 6080 was delivered;

WHEREAS, Respondent failed to submit a list of appointments in response to the certified mail delivered November 7, 2023;

WHEREAS, on June 3, 2024, the Commissioner sent certified mail # 9589 0710 5270 2131 9405 11 to Respondent's address of record again requesting a list of appointments;

WHEREAS, on June 17, 2024, Respondent responded by email advising he had received the Indiana Department of Insurance's ("Department") request for Respondent's list of appointments and supplied a list limited to Respondent's Indiana appointments only;

WHEREAS, on June 17, 2024, Respondent was notified by email that the Department needed his full list of appointment, not limited to Indiana only;

WHEREAS, Respondent has not responded to the Department's June 17, 2024 email or the July 9, 2024 follow up email as of the date of this filing;

WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days of receiving the Commissioner's request;

WHEREAS, Respondent's failure to provide the list of appointments within ten (10) days is a violation of Indiana Code § 27-1-15.6-12(g); and

WHEREAS, Indiana Code § 27-1-15.6-12(h) provides that the Commissioner may, without a hearing and in her sole discretion, suspend any insurance license held by the licensee in the event that the licensee fails to remit the list of appointments within ten (10) days of receiving the request.

IT IS THEREFORE ORDERED BY THE COMMISSIONER Respondent's license number 3092109 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the full and complete list of appointments requested by the Commissioner.
