FINDINGS OF FACT AND SUSPENSION ORDER

WHEREAS, Jaylah Askew (“Respondent”) is a nonresident insurance producer holding license # 3961657 since November 21, 2023;

WHEREAS, Indiana Code §27-1-15.6-12(g) states, in part, that a licensed producer shall furnish the Commissioner with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding the request within ten (10) days of receiving a request;

WHEREAS, on May 13, 2024, the Commissioner mailed Respondent certified mail article # 7015 1520 0003 1680 7437 requesting a list of appointments to Respondent’s address of record;

WHEREAS, on June 15, 2024, certified mail article # 7015 1520 0003 1680 7437 was returned to the Department marked as “Unclaimed/Being Returned to Sender” by the United States Postal Service;

WHEREAS, on June 27, 2024, the Commissioner emailed Respondent requesting a list of appointments to Respondent’s email address of record;


WHEREAS, on June 27, 2024, the Commissioner received confirmation that delivery of Commissioner's email to Respondent was complete;

WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days as required under Indiana Code § 27-1-15.6-12(g); and

WHEREAS, Indiana Code § 27-1-15.6-12(h) provides that the Commissioner may, without a hearing and in her sole discretion, suspend any insurance license held by the licensee in the event that the licensee fails to remit the list of appointments within ten (10) days of receiving the request.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license # 3961657 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments requested by the Commissioner.
