

**MOTION TO LIFT SUSPENSION**

The Enforcement Division of the Indiana Department of Insurance (“Department”), by counsel, Joseph Bossinger, now moves that the Suspension Order issued on June 25, 2024, in this matter be lifted. In support of this request, the Department asserts the following:

1. Jackeline Perez (“Respondent”) is a nonresident insurance producer holding license number 3899684 since May 12, 2023.
2. On May 16, 2024, the Commissioner of the Indiana Department of Insurance (“Commissioner”) emailed Respondent requesting a list of appointments to Respondent’s email address of record.
3. More than ten (10) days elapsed since the Commissioner requested a list of appointments without response from Respondent.
4. Pursuant to Indiana Code §27-1-15.6-12(g), on June 25, 2024, the Commissioner issued a Suspension Order suspending Respondent’s license number 3899684 until such a time as the Commissioner received Respondent’s list of appointments.
5. On July 31, 2024, the Department received Respondent’s list of appointments via email.

WHEREFORE, the Department respectfully requests that the Commissioner issue an order lifting the suspension of Respondent's license and all other relief just and proper upon the premise.
