**MOTION TO LIFT SUSPENSION**

The Enforcement Division of the Indiana Department of Insurance (“Department”), by counsel, Joseph Bossinger, now moves that the Suspension Order issued on January 16, 2024, in this matter be lifted. In support of this request, the Department asserts the following:

1. Kyle S. Urbasek (“Respondent”) is a nonresident insurance producer holding license number 652716 from June 3, 2009, until July 30, 2011.
2. Respondent’s license was reinstated on April 19, 2018.
3. On December 22, 2023, the Commissioner of the Indiana Department of Insurance (“Commissioner”) verified through the Producer Database maintained by the National Association of Insurance Commissioners (“NAIC”) that Respondent’s producer license in Respondent’s home state of Illinois was no longer in effect as of December 18, 2023.
4. Pursuant to Indiana Code § 27-1-15.6-8(g), the Commissioner issued a Suspension Order on January 16, 2024, suspending Respondent’s license number 652716 until such time as the Commissioner received notification that Respondent’s home state license is in effect.
5. Respondent notified the Department that Respondent’s home state license was in effect on August 13, 2024.

6. On August 13, 2024, the Department verified through the Producer Database maintained by the NAIC that Respondent's producer's license in Respondent's home state of Illinois is in effect.

WHEREFORE, the Department respectfully requests that the Commissioner issue an order lifting the suspension of Respondent's license, and for all other relief just and proper in the premises.
