## ADMINISTRATIVE ORDER NOTICE OF NONRENEWAL OF LICENSE

The Indiana Department of Insurance ("Department"), pursuant to the Indiana Administrative Orders and Procedures Act, Indiana Code § 4-21.5-1 et seq., and Indiana Code § 27-1-15.6-12, hereby gives notice to Vincent Vazquez ("Respondent") of the following Administrative Order:

- 1. Respondent was issued nonresident insurance producer license number 3287909 ("Respondent's license") on October 30, 2017.
- 2. Respondent's license expired on June 30, 2024.
- 3. Respondent submitted a renewal application with the Department on June 13, 2024.
- 4. On said renewal application, Respondent failed to disclose the following administrative actions:
  - a. A May 6, 2022, monetary penalty by the Louisiana Department of Insurance for failure to make required disclosures on a license;

- b. A September 6, 2022, license suspension by the Louisiana Department of Insurance for failure to pay fine; and
- c. A January 16, 2024, license revocation by the North Carolina Department of Insurance for failure to report other state administrative action and criminal history.
- 5. Respondent failed to report the following administrative actions to the Department not more than thirty (30) days after the final disposition of the matter:
  - a. A May 6, 2022, monetary penalty by the Louisiana Department of Insurance for failure to make required disclosures on a license; and
  - b. A January 16, 2024, license revocation by the North Carolina Department of Insurance for failure to report other state administrative action and criminal history.
- 6. Indiana Code § 27-1-15.6-12(b)(1) states, in part, the Commissioner may refuse to renew an insurance producer license for providing incorrect, misleading, incomplete, or materially untrue information in a license application.
- 7. Indiana Code § 27-1-15.6-12(b)(2)(A) states, in part, the Commissioner may refuse to renew an insurance producer license for violating and insurance law.
- 8. Indiana Code § 27-1-15.6-17(a) is an insurance law that states, in part, a producer shall report to the Commissioner any administrative action taken against the producer in another jurisdiction not more than thirty (30) days after the final disposition of the matter.
- 9. Indiana Code § 27-1-15.6-12(b)(9) states, in part, the Commissioner may refuse to renew an insurance producer license for having an insurance producer license, or its equivalent, denied, suspended, or revoked in any other state, province, district, or territory.

- 10. Following a review of public records and the materials submitted by Respondent, the Commissioner, being fully advised, now hereby notifies Respondent that Respondent has not fully met the requirements of licensure, as stated by Indiana Codes §§ 27-1-15.6-12(b)(1), 27-1-15.6-12(b)(2)(A), 27-1-15.6-17(a) and 27-1-15.6-12(b)(9), due to Respondent failing to disclose other state administrative actions in a license application, failing to timely report other state administrative actions, having a license suspended in another state, and having a license revoked in another state.
- 11. The Commissioner further notifies Respondent that, pursuant to Indiana Code § 27-1-15.6-12(d), Respondent may, within sixty-three (63) days of the mailing of this Order, make a written demand upon the Commissioner for a hearing to determine the reasonableness of this action. Such a hearing shall be held within thirty (30) days from the date of receipt of Respondent's written demand.
- 12. This is considered an agency action. This action has been initiated by the aforementioned authority. If you choose to appeal this agency action, the State of Indiana Office of Administrative Law Proceedings ("OALP") will assign an administrative law judge to preside over this matter, and subsequently you will be contacted by the OALP with more information to begin the administrative process.

WHEREFORE, based on the foregoing, the Commissioner of Insurance hereby notifies Respondent that Respondent's license shall not be renewed due to Respondent failing to disclose other state administrative actions in a license application, failing to timely report other

state administrative actions, having a license suspended in another state, and having a license revoked in another state.
