FINDINGS OF FACT AND SUSPENSION ORDER

WHEREAS, Stephanie Ramirez (“Respondent”) is a nonresident insurance producer holding license number 3979801 since February 5, 2024;

WHEREAS, Indiana Code § 27-1-15.6-12(g) states, in part, that a licensed producer shall furnish the Commissioner with a full and complete report listing each insurer with which the licensee has held an appointment during the year preceding the request within ten (10) days of receiving a request;

WHEREAS, on November 6, 2024, the Commissioner mailed Respondent certified mail article # 7022 2410 0002 7063 9045 requesting a list of appointments to Respondent’s address of record;

WHEREAS, on November 30, 2024, certified mail article # 7022 2410 0002 7063 9045 was being returned to the Department marked as “Unclaimed/Being Returned to Sender” by the United States Postal Service;

WHEREAS, on November 14, 2024, the Commissioner emailed Respondent requesting a list of appointments to Respondent's email address of record;


WHEREAS, on November 14, 2024, the Commissioner received confirmation that delivery of Commissioner's email to Respondent was complete;

WHEREAS, Respondent has failed to provide a list of appointments within ten (10) days as required under Indiana Code § 27-1-15.6-12(g); and

WHEREAS, Indiana Code § 27-1-15.6-12(h) provides that the Commissioner may, without a hearing and in her sole discretion, suspend any insurance license held by the licensee in the event that the licensee fails to remit the list of appointments within ten (10) days of receiving the request.

IT IS THEREFORE ORDERED BY THE COMMISSIONER that Respondent's license number 3979801 is hereby suspended, effective immediately, and will remain suspended until Respondent submits the list of appointments requested by the Commissioner.
