The Program also works in partnership with U.S. EPA, utilizes IDEM's Risk-based Closure Guide to issue closure and liability clarification documents for prospective purchasers and communities. Best Practices, General Procedures, and FAQs

- In most instances, without current analytical data, the Program cannot provide accurate guidance or the best next steps for redevelopment.
- Our letter review process generally takes a minimum of 120 days; in the instance a 'rush' review is requested, please provide details why that particular timeframe is needed.
- The Program recommends following our Backfill Spreadsheet. Any soil or backfill brought on a Site for redevelopment should be from a verified clean source or sampled prior to being brought on-Site.
- Not every letter issued by the Program is a 'closure' letter that provides closure of environmental conditions at a Site. Most letters issued are liability clarification letters.
- The Program recommends a prospective purchaser obtain an all appropriate inquiry compliant
 Phase I ESA prior to purchasing any property.
- A cover letter should be submitted with all letter requests. Similarly, if letter requests are missing pertinent information, the review process will not start until all documents are provided.

- 15 fuel oil USTs removed
- 23 hydraulic lifts removed
- 46 aboveground storage tanks (ASTs) removed
- 114,193 tons of petroleum-impacted soil removed (roughly equivalent in weight to the USS Abraham Lincoln aircraft carrier)
- **§** 574,006 gallons of liquid/sludge removed (60,000 gallons more than an Olympic sized swimming pool)
