

David Bausman serves as General Counsel and Ethics Officer for the Indiana Department of Natural Resources (DNR) after previously serving as the agency's Legislative and Public Policy Director. In his role at DNR, he manages DNR's legal team and works with DNR staff, members of the Indiana General Assembly, the Governor's Office, and local, state, and federal agencies on a wide range of conservation issues, including carbon sequestration, wetlands, and floodplain/drainage issues. David has a bachelor's degree in political science from DePauw University and a law degree from Robert H. McKinney School of Law at Indiana University. He lives in Johnson County with his wife and two daughters and enjoys fishing, golfing, and the Great Outdoors.

David Cook was appointed to serve as Inspector General by Governor Eric Holcomb in 2021. Cook previously served as the chairman of the Indiana Alcohol and Tobacco Commission. He was appointed by then-Gov. Pence in 2015 and reappointed by Gov. Holcomb in 2017. The Commission is responsible for regulating and licensing the alcohol and tobacco industries. The ATC also directs the Indiana State Excise Police. During his tenure as chairman, Cook built an enforcement strategy focused on compliance through education and assistance and partnered with local law enforcement to address problem establishments and decrease criminal activity. He also created industry roundtables to improve communication between the commissioners and industry members. Prior to his time at ATC, Cook served as judge of Marion Superior Criminal Division 7, a high-volume misdemeanor court. From 1995-2008, he served as the chief public defender for Marion County. Additionally, he served as a judicial officer on civil and family law cases in the Marion County Circuit Court. From 1979-1989, he worked in the Marion County Prosecutor's Office as chief trial deputy. Cook also spent time in private practice. Cook earned an undergraduate degree from Ball State University and a law degree from the Indiana University McKinney School of Law.

Justice Mark Massa was named to the Indiana Supreme Court in 2012 by Governor Mitch Daniels. He is a native of Milwaukee, Wisconsin, and came to Indiana in 1979 to attend Indiana University. He graduated from IU in 1983 with a degree in journalism, and after internships at the *South Bend Tribune* and *Milwaukee Sentinel*, he joined the staff of *The Evansville Press*, where he was an award-winning sportswriter and covered the courts and local government. In 1985, he became a deputy press secretary and speechwriter for Governor Robert Orr; he later graduated from the evening division of the IU McKinney School of Law, clerked for Indiana Supreme Court Chief Justice Randall Shepard and joined the Marion County Prosecutor's Office in Indianapolis. After serving as a Deputy Prosecutor for 15 years, including 7 years as Chief Counsel to Prosecutor Scott Newman, Justice Massa was an Assistant United States Attorney in the Southern District of Indiana, where he earned the Inspector General's Integrity Award from the Department of Health and Human Services. He served as General Counsel to Governor Mitch Daniels, chaired the Alcohol and Tobacco Commission, served on the Indianapolis Marion County Police Merit Board and was Executive Director of the Indiana Criminal Justice Institute prior to his appointment to the Court. Currently, he chairs the Lake County Judicial Nominating Commission, is a member of the Advisory Committee on the Federal Rules of Evidence, a liaison to the Juvenile Detention Alternatives Initiative, and teaches at the Indiana University McKinney School of Law.

Adrienne Meiring is the Executive Director of the Office of Judicial and Attorney Regulation, which provides staff support to the Indiana Supreme Court Disciplinary Commission, the Indiana Commission on Judicial Qualifications, and the Indiana Judicial Nominating Commission. Adrienne received her Bachelor of Arts in Criminology from the Ohio State University in 1990, graduating *summa cum laude*. She earned her Juris Doctorate with Honors from the Ohio State College of Law in 1993. Upon graduation from law school, she served as a judicial law clerk for the Honorable Rudy Lozano, U.S. District Court Judge for the Northern District of Indiana/Hammond Division. Adrienne's prior legal experience includes litigating employment discrimination cases in Indiana and Kentucky on behalf of

the Equal Employment Opportunity Commission. Adrienne also previously worked for many years as a sex crimes prosecutor at the Marion County Prosecutor's Office in Indianapolis. Adrienne serves on the board of the Association of Judicial Disciplinary Counsel. In her spare time, she likes to swim, box, paint, and spend time with her two children.

Tiffany Mulligan serves as the Chief of Staff and Chief Legal Counsel for the Indiana Office of Inspector General. She has worked as an attorney, manager, and ethics officer with the State of Indiana in various roles since 2006. She served as an attorney, Ethics Officer and the Director of the Economic Opportunity and Prequalification Divisions at the Indiana Department of Transportation. She also served as the Associate General Counsel for Governor Pence and General Counsel for the Family and Social Services Administration.
