# CONFLICT OF INTEREST SCREEN FOR TASHA VANCE May 23, 2024

#### I. RECITALS

WHEREAS, Tasha Vance is Project Manager for the Indiana Department of Transportation-Seymour District, Capital Programs ("INDOT" or "Department"); and

WHEREAS, Tasha Vance recently accepted employment with EGIS BLN USA, Inc. ("EGIS") and

WHEREAS, EGIS has a business relationship with INDOT, including active contracts; and

WHEREAS, as Project Manager for INDOT Seymour District, Capital Programs, it is possible that Tasha Vance could be assigned to participate in matters in which EGIS has an interest as part of her regular duties; and

WHEREAS, Tasha Vance's employment negotiations with EGIS created a potential decision and voting conflict of interest under IC 4-2-6-9 requiring disclosure and a formal screen; and

WHEREAS, Tasha Vance is subject to the particular matter restriction (IC 4-2-6-11(a)) and cannot assist future employers, including EGIS, with any matter she personally and substantially participated in for INDOT; and

WHEREAS, Tasha Vance may have obtained confidential information in the course of her employment with INDOT and has an affirmative duty to protect such information from disclosure and to refrain from relying on such information for the benefit of herself or future employers.<sup>1</sup>

NOW THEREFORE, Tasha Vance, Project Manager for INDOT, for her remaining tenure with INDOT, or until she discontinues employment negotiations with EGIS BLN USA, Inc., agrees to in all ways follow, adhere to, and satisfy the terms of the following Conflict of Interest Screen. Tasha Vance must adhere to terms three (3) and four (4) regarding the particular matter restriction and confidential information in perpetuity.

#### II. CONFLICT OF INTEREST SCREEN

- 1. Tasha Vance shall not participate in any decision or vote, or any matter related to such decision or vote, in which EGIS has a financial interest.
- 2. Tasha Vance is screened from participating in any present or future contract or other matter involving EGIS.
- 3. Tasha Vance shall not assist any future employers, including EGIS, with any matter she personally and substantially participated in while employed by INDOT. This restriction applies in perpetuity, for the life of the particular matter.
- 4. Pursuant to his duty under Ind. Code §5-14-3-10, Tasha Vance shall not disclose or otherwise rely upon information classified as confidential under Ind. Code §5-14-3-4. This restriction applies in perpetuity, so long as the subject information is deemed confidential.

#### III. EMPLOYEE AFFIRMATION

I have read and understand the terms of the foregoing Conflict of Interest Screen, and will in all ways follow, adhere to, and satisfy the above stated restrictions on my participation in any decision or vote in which EGIS BLN USA, Inc. has a financial interest. I understand that the first two (2) terms of this screen terminate upon my leaving the Department or the discontinuation of negotiations with EGIS, whichever occurs first. I further understand that terms three (3) and four (4) regarding particular matters and confidential information respectively, apply in perpetuity, for the life of each matter and so long as the subject information is deemed confidential.
