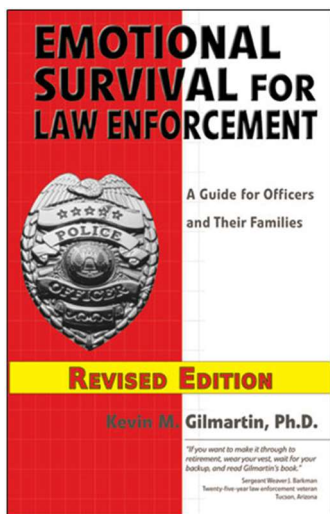

Training for officers and their spouses with the skills of emotional survival are just as important.

- Dr. Gilmartin is a law enforcement behavioral scientist with over 20 years in law enforcement.
- It is a fact, that the law enforcement profession loses more officers to self-destruction than it does to felony death.
- Law enforcement professionals are constantly exposed to a lifetime of events and people that violate their expectations of how things "should be" thus transforming the idealistic and committed officer into a cynical, angry individual.
- The goal of this course is to have the law enforcement professional look inward and understand the potential psychological impact a LEO career causes in their personal life, their relationships, the impact on their children and spouse, and to develop specific preventative strategies for overall emotional survival.
