LEGAL NOTICE OF PUBLIC HEARING

State Road 8 / (also known as 7th Street) Access Management Project

The Indiana Department of Transportation (INDOT) will host a public hearing on Thursday, August 8, 2024 at Middaugh Hall, DeKalb County Fairgrounds, 708 South Union Street, Auburn, IN 46706. The doors will be open at 5:30 p.m. to give participants time to view displays and talk to representatives prior to the meeting. The formal presentation will begin at 6:30 p.m. with time allotted following the hearing for questions to the project team.

The purpose of the public hearing is to offer all interested persons an opportunity to review and comment on preliminary plans for the State Road 8 (SR 8) Access Management Project in Dekalb County, Indiana. The proposed project is located on SR 8 (locally known as 7th Street) from 0.10 miles East of the I-69 Interchange to 0.60 miles East of the I-69 Interchange in the City of Auburn, Indiana.

The need and purpose of the SR 8 roadway project (Des. No. 2100012) stems from the higher-than-average crash frequency and severity rates. Many commercial drives along the corridor affect traffic flow and contribute to the high crash rate. Significant traffic congestion occurs at the traffic signals during the peak periods. There is also a lack of sidewalks in many areas along SR 8.

The preferred alternative addresses these needs by removing some commercial drives and creating a center raised concrete median to replace the Two-Way Left Turn Lane (TWLTL). To allow access to businesses along the corridor, Left Turn/U-turn openings will be installed in three locations between the Touring Drive and Grandstaff Drive intersections. Additional turn lanes will be added at the SR 8/Touring Drive and SR 8/Grandstaff Drive intersections to increase capacity and reduce congestion.

An eastbound right turn lane will be constructed from approximately 300 feet east of Touring Drive to 1,000 feet east of Touring Drive. The right turn lane will replace the existing frontage road along the south side of SR 8. New sidewalks will be installed along both sides of SR 8 and new curb ramps that meet Americans with Disabilities Act (ADA) requirements will be installed at intersections.

Construction is anticipated to occur in 2026.

Right-of-Way acquisition from 24 parcels will be required. A total acquisition of 1.23 acres of permanent right-of-way is anticipated.

Federal and state funds are proposed to be used for construction of this project.

INDOT requests comments be postmarked by Friday, August 23, 2024, to be included as part of the public hearing record.

With 7 (seven) days advance notice, INDOT will provide accommodations for persons with disabilities with regards to participation and access to project information as part of the hearing's process including services for the hearing impaired, services for the sight impaired, and other services as needed. In addition, INDOT will provide accommodations for persons with Limited English Proficiency (LEP) including language interpretation services and document conversion.
