### Opportunity for Public Comment on Eastern Heights Utilities' Rate Case

**WHAT:** The Indiana Utility Regulatory Commission (Commission) will hold a field hearing in Bloomfield to hear from the public on the rate case petition of Eastern Heights Utilities, Inc. under Cause No. [46084-U](#).

**WHEN:** Thursday, September 5, 2024, at 6 p.m. local time

**WHERE:** Bloomfield Middle and High School (Cafeteria)

Bloomfield, Indiana 47424

**WHY:** Eastern Heights Utilities filed a petition before the Commission requesting approval to increase its rates and charges for water utility service.

**HOW:** During field hearings, ratepayers have the opportunity to speak directly to the Commission or submit written comments. Please note, though, that because this is a pending case, the Commissioners and Judge will not answer questions or engage in any discussion about the case.
