Request:	The Commission approved a Settlement Agreement between Crawfordsville and the Indiana Office of Utility Consumer Counselor ("OUCC") in Cause No. 45420, which required Crawfordsville to pass back damages awarded to Crawfordsville from its former rate consultant who performed a rate design error in its previous rate case, Cause No. 44684. As such, this filing has been made to facilitate the disbursement of such credits to Crawfordsville's customers. The net settlement credit has been calculated based on a \$375,000 final settlement amount less applicable litigation fees of \$143,677.26, which results in \$231,322.74 to be passed back to customers. Crawfordsville indicated it is experiencing a software system upgrade in August 2024 and will need extra time to test the bill credit before moving it to the live system. Therefore, Crawfordsville proposes to implement the credit on customer bills during the October 2024 billing cycle.
