Meeting called to order at 5:06pm

#### **Approval of Minutes**

Minutes for the February 26th Health Board Meeting were unanimously approved as written.

#### **Division Reports**

Division Reports were briefly discussed and unanimously accepted into record as submitted.

#### **Health Officer Comments**

Dr. Woods provided information regarding the challenges and delays in implementing MOU's for HFI funds.

#### **Old Business**

- a) On-Site Septic Ordinance Jeff Couch presented the proposed On-Site Septic Ordinance stating the major changes include removal of the bond & insurance requirement for installers, the addition of holding tank regulations, exemptions for clay soils and soil pits. The 2-acre lot size requirement was questioned, discussed and reverted to a 1-acre requirement. Sarah Seward motioned to approve the Ordinance with the 1-acre amendment, 2<sup>nd</sup> by Brandy Poling, unanimous consensus. Ordinance will be forwarded to the Commissioners for adoption then forwarded to IDOH TRP.
- b) Tattoo/Body Piercing Ordinance Ordinance was revisited to amend the Indiana codes cited in Section D. Discussion was held around adding language requiring operators to assure artists were not impaired while providing services, it was decided enforcement would be too challenging. Dr. Hoeksema motioned to approve the ordinance as submitted, 2<sup>nd</sup> by Poling, unanimous yeas. Ordinance will move to Commissioners for adoption.
- c) Fee Ordinance Ordinance was revisited to add "In accordance with IC 16-20-1-27" in the preamble of the proposed Grant County Fee Ordinance. Seward motioned to approve the ordinance as written, 2<sup>nd</sup> by Poling, unanimous approval. Ordinance will move to Commissioners for adoption.

### **New Business**

- a) Introduction of New Employees Previously part-time, moved to full time nurse Beverly Penrod and new hire EHS Josh Keller were introduced to the board.
- b) 2025 Budget the proposed 2025 budget was discussed. The requested Nurse Health Educator position will be changed to Health Educator as a nursing degree will not be required. Dr. Hoeksema motioned to approve the budget, with the correction, 2<sup>nd</sup> by Seward, board unanimously approved. Proposed budget will move to IDOH and Grant County Council.
