Renata Williams, Director of CARE: Outlined the mission of the CARE Unit, the social determinants of health and their connection to our work. She also reviewed our health promotion and maternal and child health programs.

Alissa Balke, Assistant Director of CARE: Outlined the CDC's Community Health Worker (CHW) and lead poisoning prevention programs.

Ellen Reilander, ESQ., asked Renata to explain the schedule of the EMBER classes.

Renata Williams: Classes are held every Tuesday and focus on a specific trimester (for example: the 1st Tuesday of the month covers the first trimester, 2nd Tuesday of the month covers the second trimester, etc.). Mothers are encouraged to continue to attend these classes postpartum as needed. Classes will be held at The Beacon Resource Center located at 4210 Lincoln Way West, in South Bend.

Ellen Reilander, ESQ., asked who will be running these classes.

Renata Williams: The Maternal Infant Health Program will be run by our MIH Coordinator; and the Postpartum support program will be run by a Postpartum Support Group Facilitator who will be a contractual employee.

Ellen Reilander, ESQ., asked if the chart showing the initiatives of the unit has been helpful to any community partners.

Renata Williams: We have data sharing agreements with some of the community partners that we can share that information with.

We have a health fair coming up where we reached across county lines to bring all community resources together in one spot, so community members would be aware of where they can go.
