COVID-19 Cases Update & Limit on Social Gatherings

St. Joseph County- As of today, St. Joseph County is reporting 1,651 active cases (red as it relates to County metrics), and our average is 119 cases per day (red) in the last seven days. Test positivity rate is 6.7% (as of 10/23/2020) (yellow). The R0 is 1.14 (as of 10/24/2020).

Individuals who have been identified as a close personal contact, due to exposure to someone positive for COVID-19, must quarantine for 14 days per Centers for Disease Control & Prevention and the Indiana Department of Health. An individual cannot "test out" of quarantine; the incubation period can be anywhere from 2-14 days following exposure, meaning that someone can be infectious (regardless of whether they have symptoms or not) as early as 2 days post exposure or as late as 14 days after. Therefore, close contacts must remain in quarantine for the 14-day period.

With community transmission increasing, we want to strongly urge our residents to take precautions this Halloween weekend. If your family chooses to participate in events, please do not congregate with those outside of your family unit, mask up, and practice physical distancing. Hand hygiene is an essential piece of prevention so hands should be washed/sanitized frequently.
