## IHCP to mass adjust/reprocess CIH, FSW and TBI waiver claims that were denied incorrectly

The Indiana Health Coverage Programs (IHCP) previously announced the addition of the following waiver services, effective for dates of service (DOS) on or after July 1, 2024:

- Home Modification Assessment services were added to the Community Integration and Habilitation (CIH) Waiver, Family Supports Waiver (FSW), and Traumatic Brain Injury (TBI) Waiver (*IHCP Bulletin BT202479*) – see Table 1
- Career Exploration and Planning services were added to FSW and CIH Waiver (*IHCP Bulletin BT202480*) – see Table 2
- Structured Family Caregiving services were added to the TBI Waiver (*IHCP Bulletin BT202482*) – see [Table 3](#)



Claims for these services with DOS from July 1, 2024, through Sept. 6, 2024, may have been denied inappropriately, and will be mass adjusted or reprocessed. Providers should see adjusted/reprocessed claims on remittance advices (RAs) beginning Nov. 6, 2024, with internal control numbers (ICNs)/Claim IDs that begin with 52 (mass replacements non-check related) or 80 (reprocessed denied claims).
