IHCP updates the ICD-10-CM code list, effective Oct. 1, 2024

The Indiana Health Coverage Programs (IHCP) previously published billing information for the annual update of International Classification of Diseases, Tenth Revision (ICD-10) Clinical Modification (CM) diagnosis codes and Procedure Coding System (PCS) procedure codes in *IHCP Bulletin* [BT2024163](#).

The IHCP is publishing additional information and corrections to the annual ICD code update. These changes apply retroactively to dates of service (DOS) on or after Oct. 1, 2024.

Emergency Department Autopay List for MCEs

The following codes were added in error to the list of codes that the state requires managed care entities (MCEs) to include on their emergency department autopay list, if they use such a list.

These codes are being removed from the Emergency Department Autopay List (accessible from the [Codes Sets](#) page at in.gov/medicaid/providers) retroactive for DOS on or after Oct. 1, 2024.



Table 1 – Diagnosis codes being removed from the state’s MCE Emergency Department Autopay List, retroactive for DOS on or after Oct. 1, 2024

Diagnosis code	Description
G9345	Developmental and epileptic encephalopathy
T45AX2D	Poisoning by immune checkpoint inhibitors and immunostimulant drugs, intentional self-harm, subsequent encounter
T45AX2S	Poisoning by immune checkpoint inhibitors and immunostimulant drugs, intentional self-harm, sequela
T45AX3S	Poisoning by immune checkpoint inhibitors and immunostimulant drugs, assault, sequela
T45AX4D	Poisoning by immune checkpoint inhibitors and immunostimulant drugs, undetermined, subsequent encounter
T45AX4S	Poisoning by immune checkpoint inhibitors and immunostimulant drugs, undetermined, sequela
T45AX5D	Adverse effect of immune checkpoint inhibitors and immunostimulant drugs, subsequent encounter
T45AX5S	Adverse effect of immune checkpoint inhibitors and immunostimulant drugs, sequela
T81320S	Disruption or dehiscence of gastrointestinal tract anastomosis, repair, or closure, sequela
T81321S	Disruption or dehiscence of closure of internal operation (surgical) wound of abdominal wall muscle or fascia, sequela
T81328S	Disruption or dehiscence of closure of other specified internal operation (surgical) wound, sequela
T81329D	Deep disruption or dehiscence of operation wound unspecified, subsequent encounter
T81329S	Deep disruption or dehiscence of operation wound, unspecified, sequela

Behavioral and Primary Healthcare Coordination

The Behavioral and Primary Healthcare Coordination (BPHC) program was designed to help individuals with serious mental illness (SMI) and co-occurring physical healthcare needs manage their care by providing logistical support, advocacy and education. The BPHC service is targeted to individuals who meet the BPHC eligibility criteria, which includes a qualifying primary mental health diagnosis.

Effective for DOS on or after Oct. 1, 2024, the IHCP will add the diagnosis codes in Table 2 to the list of qualifying BPHC diagnosis codes. Corresponding updates will be made to *Behavioral and Primary Healthcare Coordination (BPHC) Codes*, accessible from the [Codes Sets](#) page at in.gov/medicaid/providers.
