IHCP reminds providers about changes to site-of-service adjustments

In *Indiana Health Coverage Programs (IHCP) Bulletin [BT2024159](#)*, the IHCP announced the changes to physician site-of-service policies to coincide with the January 2024 Office of Medicaid Policy and Planning (OMPP) Healthy Indiana Plan (HIP) Rate Equalization Project. Table 1 reflects the changes made to site-of-service adjustments for the fee-for-service (FFS) delivery system.



For FFS claims, these changes are effective retroactive for dates of service (DOS) on or after **April 1, 2024**. For managed care entities (MCEs), these changes were effective for claims with DOS on or after **Jan. 1, 2024**.

FFS claims submitted for these services with DOS beginning April 1, 2024, through Sept. 25, 2024, will be mass adjusted or reprocessed. Providers should see adjusted/reprocessed claims on remittance advices (RAs) beginning Jan. 8, 2025, with internal control numbers (ICNs)/Claim IDs that begin with 52 (mass replacements non-check related).

As a reminder, effective April 1, 2024, IHCP physician rates have been aligned with 100% of Medicare rates, as published in *IHCP Bulletins [BT2023149](#), [BT2023150](#) and [BT2023172](#)*. The IHCP is using the 2023 Medicare practice expense (PE) relative value units (RVUs). The PE RVU should match the same period as the fee schedule being used (for example: Jan. 1, 2025, rates will use the 2024 Medicare PE RVUs and will continue this way annually).

 - 62 Comprehensive outpatient rehabilitation facility

- Medicare POS codes
 - 02 Telehealth
 - 19 Outpatient hospital-off campus
 - 21 Inpatient hospital
 - 22 Outpatient hospital – on campus
 - 23 Emergency room – hospital
 - 24 Ambulatory surgical center (ASC)
- 26 Military treatment facility
 - 31 Skilled nursing facility (SNF)
 - 34 Hospice
 - 41 Ambulance – land
 - 42 Ambulance – air or water
 - 51 Inpatient psychiatric facility
 - 52 Psychiatric facility – partial hospitalization
