IHCP changes billing instructions for Prevocational services under FSW and CIH Waiver

The Indiana Health Coverage Programs (IHCP) and the Division of Disability and Rehabilitative Services (DDRS) Bureau of Disability Services (BDS) announce changes to billing requirements for Prevocational services, under the Community Integration and Habilitation (CIH) Waiver and the Family Supports Waiver (FSW).

Table 1 lists the new procedure code/modifier combinations and the associated descriptions (indicating participant-to-provider ratio and service delivery setting) for Prevocational services, effective for dates of service (DOS) on or after July 1, 2024. Billing *must* match the approved service authorization (SA), or the claim will be denied.

<u>Table 2</u> shows the procedure code/modifier combinations that will be end-dated effective June 30, 2024.

Prevocational services provide learning and work experiences, including volunteer work, where the individual



can develop general, non-job-task-specific strengths and skills that contribute to employability in integrated community settings. For more information about the service, see the <u>DDRS Home- and Community-Based Services (HCBS)</u>
