

# AES Indiana Electric Rate Case

IURC Public Field Hearing - Cause #45911

## Two separate state agencies are involved in tonight's hearing.

The **Indiana Utility Regulatory Commission (IURC)** is holding the hearing to receive public comments on the pending case. It will make a final decision next year.

The **Indiana Office of Utility Consumer Counselor (OUCC)** represents the public in Commission cases & facilitates public participation in these hearings.

**The OUCC has until Oct. 12, 2023 to take a formal position.**  
OUCC attorneys, accountants, engineers, & additional analysts are reviewing the utility's testimony & exhibits.

## The Case

AES Indiana's request would raise annual revenues by \$134 million. Monthly service charges for most residential customers would rise from \$16.75 to \$25.00. The volumetric part of each customer's base rate would also increase.

In its testimony, the utility states it is seeking the increase due to numerous infrastructure projects, a new data & operations system for customer service, meter data management, field services management, vegetation management costs, & inflationary impacts on operational costs.

The utility's current base rates were approved in 2018.

Additional parties that have intervened in this case include the Citizens Action Coalition of Indiana, The Kroger Co., & industrial customers (including Allison Transmission, Eli Lilly & Co., Indiana University, Indiana University Health, Marathon Petroleum, & Messer). Any testimony they file is due by Oct. 12, 2023.

A settlement agreement is possible in any legal proceeding. If an agreement is reached, the settling parties are required to present evidence showing it to be in the public interest. The IURC may approve, deny, or modify any settlement it considers.

**A second public hearing will be held on Oct. 2 at New Augusta Public Academy North (6450 Rodebaugh Rd.).**

## Field Hearing Basics

- Sole purpose: Consumer testimony.
- Written comments & spoken comments carry equal weight.
- The IURC cannot answer questions. This is a legal proceeding & it is bound by the same ethical rules as a judge in court.
- No utility presentation. Utilities make their cases in writing.
- OUCC staff are available to answer questions.
- No final decision tonight. Order expected Spring 2024.

## AES Indiana Rate Case Timeline

All dates are subject to change. A settlement is possible in any legal proceeding.

**Oct. 6, 2023**

**Public Comment Deadline**

*The OUCC accepts written comments online & by mail.*

**Oct. 12, 2023**

**OUCC Testimony**

*OUCC attorneys & technical experts will file recommendations.  
Intervenors may also file testimony.*

**Nov. 8, 2023**

**Rebuttal Testimony**

*The utility may file testimony in response.*

**Dec. 4, 2023**

**IURC Evidentiary Hearing Starts**

*Attorneys for the OUCC, utility, & intervenors may cross examine each other's technical witnesses.*

**Dec. 2023/Jan. 2024**

**Closing Briefs**

*The OUCC, utility, & intervenors may file closing briefs in the weeks following the evidentiary hearing.*

**Spring 2024**

**Order**

*The IURC issues a final order after considering all evidence.*
