State questioned respondent about how she's been "disrupted." Discussed hospitalizations, related diagnoses and approximately 700 emails sent to the state. Last worked as a pharmacist in September 2023. Left CVS voluntarily at that time.

Jack testified. Admitted State's Exhibit 8, 1 - 6, 7. Respondent and State closed. State recommended 2-year suspension or revocation.

After having considered the evidence presented and taking official, judicial notice of the pleadings, evidence and orders in this matter the Board moved to place Respondent's license on INDEFINITE SUSPENSION for 2 years and completing an evaluation before petitioning for reinstatement.

Patients complete a medication in-take form. In July 2024 dispensed 28 prescriptions across the country. First internet pharmacy that's come before the board. Montana license in good standing. No plans to sterile compound.
