# Paul Hollern, D.C., License No. 08001101A, Cause No. 2011 IBCE 0015

Respondent appeared in person and was not represented by counsel regarding a Petition to Reinstate Suspended License scheduled before the Board. The State of Indiana was represented by Ryan Eldridge, Deputy Attorney General and the court reporter sworn in for this matter was Margie Addington with Accurate Reporting Services.

In a preliminary matter, Mr. Eldridge requested that the Notice of Proposed Dismissal be set aside.

After discussion, the Board made a Motion to Set Aside the Proposed Dismissal.

On August 2, 1991, Dr. Hollern voluntarily entered into an Agreed Order with the Kentucky Board of Chiropractic Examiners admitting that he failed twice to include notice of the seventy-two (72) hours right of rescission in his advertisements and solicitations. He received a \$1,000.00 fine for the violations and was required to send letters regarding the 72-hour right of rescission to each consumer that responded to the advertisement in question.

On January 25, 2005, he voluntarily entered an Agreed Order with the Kentucky Board admitting that he advertised free or discounted services in the Bullitt County User Friendly telephone directory without giving adequate notice of the seventy-two (72) right of rescission as required by Kentucky laws. Dr. Hollern also failed to send a copy of the written advertisement to the Kentucky Board when it was published as required. He was issued a reprimand, and a \$100 fine, and was required to notify all consumers who responded to the advertisement about the rescission provision.

Dr. Hollern explained that he was charged with electronic interference and was found guilty of the same. About February 5, 2007, a grand jury indicted him for charges related to his use of audiovisual recording devices as part of a chiropractic training program he managed. The counts included but were not limited to health care fraud (18 U.S.C. § 1347), intentional interception of oral communications (18 U.S.C. § 2511(1)(a)), HIPAA violations (42 U.S.C. § 1320d-6), and retaliation against a witness (18 U.S.C. § 1513(e)). Respondent was convicted of intentional interception of oral communication. He was sentenced to one (1) year of probation with home confinement for the first six (6) months.

He indicated he had moved from Kentucky to Florida. He wants to teach in a Chiropractic College but must have an active license to do so. He has applied for a FL license. He stated he does consultations in states that do not require a license weekly.

The last time he had an active license was in 2007.

After having considered the evidence presented, and taking official, judicial notice of the pleadings, evidence, and orders in this matter the Board moved to APPROVE REINSTATEMENT upon receipt, review, and approval of the following:

- Renewal application with \$200 fee.
- Payment of the \$2,000 FINE issued previously by the Board.
- Retake the Indiana Law exam.
- Proof of 240 hours of Continuing Education.
- Copy of email regarding correct address.
- Proof he has completed his house arrest and criminal probation and any requirements that came with it.
- Proof of taking and passing Part 4 national exam through the Florida Board.
- Copy of Florida requirements for licensure.
