8. DISCUSSION

A. Practice Ruling

1. Question:

Title 842 states that a PT can supervise no more than the equivalent of 3 full-time PTAs if face-to-face daily consultant is not occurring. Does this mean that a PT can supervise 2 full time PTAs and 2 part-time PTAs? Can you please provide clarity on what "the equivalent of 3 full time PTAs" means? Also, please clarify what face-to-face contact entails. Does FaceTime or Zoom count? When daily interaction is face-to-face is the ruling that 4 PTAs may be supervised by 1 PT? Also, where is the source doc for this ruling?

Board Answer:

The board does not offer any additional information to this question.

2. Question:

Clarify if "direct supervision" of a PT aide means the PT must be within the line of sight while the aide performs designated tasks, or can the PT simply be present in the building?

Board Answer:

Refer to the definition of the PT aide. A PT aide may only be used in an operational task. Refer to the definition of a task and then go to the definition of direct supervision. Refer them to the definitions located in APTA.org level of supervision PT and PTA are always responsible for the PT Aide.

3. Question:

Provide clarity if a physical therapist with an Indiana license practicing in Indiana may provide wellness services, such as sports performance enhancement or personal training, without being restricted to the Physical Therapy Practice Act requirement of requiring a referral from a qualified provider after 42 days. This would be in a case where no physical therapy services related to a PT plan of care for rehabilitation/habilitation are provided, truly wellness or personal training.
