The question of whether packagers who are registered with the FDA as manufacturers need a WDD license was raised. The Board determined that if the packagers are licensed as FDA approved manufacturers, then WDD licensure is not required per IC 25-26-14-1(b).

  - SEA 262: the Board will not develop rules related to biosimilars at this time.
  - SEA 421: the Board invites the NABP to present of the VPP/inspection program for consideration and possible approval as a board approved provider of inspection reports.
  - HEA 1218: The Board directed staff to work with advisory council to determine whether rules must be promulgated to give guidance to opioid treatment practitioners on their INSPECT checking obligations.
