Education Compliance Officer Toni Herron stated that the construction completed at the IU South Bend campus greatly enhanced the learning space available for use by students. She cited her only concern as the need for support personnel such as program technicians, to ensure that the building could be used to full potential. A motion was made and seconded to approve the construction and allow immediate occupancy and use. Cooper/Sego 6-0-0.

Dr. Samantha Cussen appeared on behalf of the program. Dr. Cussen stated that Manchester is requesting a lift of the cap on cohort size and to gain approval for substantive change to the curriculum. The Faculty have reviewed the curriculum and determined that there is overlap in some areas and that an additional course offering in dosage calculations is necessary. This will result in a decrease of nursing major credits to 65 but total of 120 credits will still be required for program completion, with the additional hours consisting of electives. Aggravating factors: limited time in nursing prior to misconduct, bad history with ISNAP, behaviors demonstrated at work (including having syringe, not taking UDSes when asked, unsafe treatment of patients with titrated drips). Cooper/Magers 8-0-0.

XV. Personal Appearances (Rooms 1&2, 11:00 a.m., Conducted by Kim Cooper and Rena Magers)

- 1. Brian Spond: Spond appeared for a positive response. He was arrested in 1999 for retail theft, June 2004 arrested for public indecency for urinating in public, and was ticketed by DNR for trespassing. He graduated in May 2014 and has attempted the NCLEX 4 times unsuccessfully. The ALJ recommended to deny the application for licensure on basis of length of time out of school and that the applicant should return to school.
- 2. Brantley Bielec: Bielec appeared with counsel for a positive response. He graduated in December 2021 and passed the NCLEX in January 2022. LPN in Indiana and compact license in Texas. In early 2022 a medication error occurred with a patient at a nursing home. The patient was misidentified during the overnight shift. He had only been at the facility a couple days, did not have orientation, and had not met the patients previously. He notified a NP of the med error and monitored the patient. After the patient became more sedated than her baseline, she was transferred to a hospital, monitored, and transferred back to the facility 12 hours later. After the incident more training was offered to him. A Texas state surveyor came in for an unannounced visit, which prompted the employer to suspend him and later terminate him. Texas took action on his license and assigned remedial education. Bielec completed the education before the status of his license was changed, which in turn prevented it from being changed. Texas did not order probation and his license is currently unencumbered. The ALJ recommended allowing him to test and get a license free and clear. Mitigating factors: new to facility, little experience, working in a position for which he wasn't hired, and resident confusion.
- 3. Coresha Aberdeen: Failed to appear for second time. The ALJ recommended to deny the application.

- 4. Chaznia Dawson: Dawson appeared for a positive response on an initial application. In 2017 she was in a domestic violence relationship where her partner one day was upset that that she didn't wake him up for work. Once she was taking him to work but an argument occurred, and he began shooting a gun in the air while she was in the vehicle. He was frustrated and exited the car. A witness called in and said she tried to hit him with the car when turning around. Police showed up and she was arrested and charged with Criminal Recklessness. The witness never showed up in court. In 2021 she was charged with battery against a neighboring cosmetology professional that she had an ongoing feud with. Charges were later dismissed. In December 2023 she got off work and drove a friend's car home that had expired plates. She was pulled over for the expired plates but was arrested because the car smelled like marijuana. Police searched the car and found both marijuana and gummies. She was charged with possession of marijuana. She graduated in April 2024 and is working as a LPN on a temp license for a temp agency. The ALJ recommended her to test and then be licensed on probation for a minimum of 1 year. She will need to provide a signed copy of her probation order, quarterly reports from her employer, and keep the Board informed of any changes in her personal contact details and legal status. She will need consistent full time supervision. Aggravating factors: need to take more responsibility and inconsistencies of statements.
- 5. Donna Cummings: Cummings appeared for reinstatement of her RN. She had kept her license active until 2007. She became and was working as a PA until her position was eliminated in pediatric dermatology with IU Health. She since has had difficulty finding work as a PA and decided she would like to get back into nursing so there would be more employment opportunities. She said she feels competent and has another 8-10 good years to work before she retires. The ALJ recommended she complete a NCLEX review course that has a readiness predicted value score at the end, and then pass the NCLEX. She also should take an NCLEX review course.
- 6. Emily Templin: Failed to appear. Reschedule.
- 7. Eno Victoria Inwang: Failed to appear. Reschedule.
- 8. Gertrudes Goze: Goze appeared for her application and exam status. She was educated in the Philippines, graduated in 2008, and took and passed the NCLEX in Las Vegas, Nevada in June 2009. She worked as a RN in the Philippines and arrived in Indiana in May 2023. Was advised to apply for a license and submitted both a RN and a RN compact application. She does not have a license from another state so must take the NCLEX again. CGFNS is good. The ALJ recommended that she set for the NCLEX, but since the exam has changed since 2008 she would need to take a NCLEX predictor review. She would also need to complete a RN refresher course with a clinical component.

- 15. Rachel Jachim: Jachim appeared for a pending APRN, reinstatement of RN, and for a positive response. She got licensed in Illinois in 2012 and then endorsed to Indiana in 2014 with her RN 28217288A. She had an OWI in 2014 that got her probation and complied with probation but never had a withdraw hearing and allowed the license ending in 88A to expire since she was working in Illinois. She got married in 2016 and changed her name. When trying to reinstate her Indiana license 88A in 2019, she was instructed to get a new license which is now expired

(28253812A). She never worked under 88A but did work under 12A here in Indiana. The pending reinstatement application is for 88A. She is not out of practice and her Illinois license is free and clear. ISNAP representative checked NURSYS and confirmed both RN and NP are unencumbered. The ALJ recommended renewing the 12A license free and clear. The 88A license needs to be closed out and possibly merged. Conversation with Board Director Hart will be needed to further discuss.

- 16. Sandra Johnson: Failed to appear. Reschedule.
- 17. Brooke Giorgio CONTINUED
- 18. Jessica Kirby: Kirby appeared for a positive response for underage drinking since her last application. She graduated in May 2024. Sat for NCLEX in June but didn't pass. Was at a party and had several drinks. Cops showed up to the party and she chose to not run but present herself to the cops and comply with their request. She did a breathalyzer, blew a 0.04, called her mom and got a ride home. She signed a pretrial diversion which is set to be complete in August. Has already taken an online course and is set to take an in-person class. She has been studying for next NCLEX, focusing on missed questions, and doing 85 questions daily. The ALJ recommended to allow her to retest and get a free and clear license. Mitigating factors: blood alcohol was 0.04, no history with alcohol and other arrest, first time incident, called for a ride, was transparent, and accepted responsibility.
- 19. Cynthia Gunkel: Failed to appear. Reschedule.
- 20. Heather Soucy CONTINUED
- 21. Cynthia Hunter: Hunter appeared for a denied renewal due to failure to show up for a PA. Now she has a new renewal with a positive response. She explained that she was terminated from a job in July 2022 that she had worked for 5 months. Her boss said she had lied on forms about vaccinations. She initially was told she could get verbal consents from coworkers about their vaccine status and due to a deadline set was taking verbal consents over the phone. Her boss later changed her position on her decision to count verbal consents and terminated her. She then took a new job and was there from August of 2022 to February 2024. A PA was requested for her 2023 renewal for which she did not appear. PA was set twice and due to not appearing the renewal was denied in February 2024. She said she had gotten a letter from OAG saying everything was good while being marked valid to practice while being reviewed. Later when she called the Nursing Board she was told she had missed an appearance but had never received notice for the appearance. She also shared she received a warning letter from OAG but not a Letter of Reprimand. The ALJ recommended to renew her license free and clear. Mitigating factors: she has had an extended relationship at a senior living facility, been a nurse for 15 years, only issue was with a specialty hospital where the miscommunication occurred, was transparent with the Board.
- 22. Ashley Staten CONTINUED
- 23. Jade Reed: Reed appeared for LPN being on probation and for initial application for RN. She had a DUI traffic stop in 2018 and a DUI single vehicle accident in 2020. Applied in August 2023 and appeared in April 2024 for positive response on LPN license and Board placed her on probation for 1 year. All legal items for criminal case were completed before she applied with PLA. Board recommended an ISNAP evaluation and a RMA. The ALJ recommended she be allowed to set for NCLEX and then issue RN license with same probation terms as on LPN and to continue submitting ¼ reports from employer and 2 years of active practice. Mitigating factors: transparency and ISNAP confirmed compliance with program.
- 24. Ernest Emery CONTINUED

- 25. Denise Williams: Williams appeared for reinstatement of an expired license over 10 years old. She had stepped away from nursing to raise her family. Her license lapsed in 2005. At that time she was in an apartment and between houses and missed the mailed renewal reminder. Currently she is in a Master's program and wants to get involved in nursing research. She wants an active license so she can actively do research. When asked if she feels competent as a nurse she replied yes. It was noted that current standards have changed. The ALJ recommended she complete a NCLEX review course that has a readiness predicted value score at the end scoring 95% or higher. Once completed since the course is self-paced, she would be cleared to NCLEX. She also should take an online RN refresher course.
- 26. Rodney Lancour CONTINUED
- 27. Bernadetta Krzyszkowski: Krzyszkowski e-mailed to notify the Board that she was withdrawing her application. The ALJ accepted her request to withdraw her application for licensure.
- 28. Kate Obot: Obot appeared for initial licensure and review of education/graduation dates in January 2002 and December 2013. After having raised her family and dealt with several losses, she's ready to stand on her own two feet and do nursing as this is her passion. She has attempted NCLEX twice and failed. Initially applied in 2017 and abandoned application in 2018. Then applied in 2020 and failed twice to appear for PA which prompted denial of application. Current application was received in September of 2023. The ALJ recommended she be allowed to set for the NCLEX, but would need to complete a NCLEX review course that has a readiness predicted value score at the end scoring 95% or higher. She should also work with a tutor to prep for exam since there have been changes since her previous attempts. Due to this being very close to the 10 year mark, it was explained to her that she would have one chance to pass the NCLEX before having to go back to school. Mitigating factors: date of initial application was in September 2023 which is just barley ahead of her 10 year mark of graduating in December 2013, since she had to wait for personal appearance to be scheduled exam approval was granted, applicant agreed to do prep course and had been educated to exam changes, applicant has clear understanding and agrees to this is final attempt, if fails must go back to school.
- 29. Kristen Butcher: Butcher appeared for a positive response on her initial application. Graduated in May 2024. She had a charge from 2018 of driving while suspended and failed to appear. She said the matter was brought to her attention when trying to register for her NCLEX. A warrant was lifted on July 12, 2024, and had a pretrial conference scheduled for July 19 that her lawyer was going to attend with her. She said that her nursing background check did not find the traffic violation. She said there have not been problems since September 2019. There was an issue with a family member using her identity in 2013. Went to court for that and took a pretrial diversion agreement per the advice of her counsel. The ALJ expressed concern that she did not follow the rules when she submitted her application and failed to answer yes, which was deemed application fraud. The ALJ recommended to approve to test, then put license on probation for 6 months, signed board order by her and her employer, ¼ reports, active practice for 6 months, and notify board of any changes in her personal contact information and legal status. Mitigating factor: transparency during appearance. Aggregating factors: repetitive behavior of same issues and application fraud.
