New Rule Questions - Cyndi Gianneschi

Client list report — what should an applicant do, how should it be presented to the board — the board wants to review the actual report and isn't concerned with the name of the clients, just for the experience associated with the appraisals submitted. The hours are what matter for the experience.

The applications coming in now utilize the new rules implemented in October 2023, which in reality are an easier pathway and clarity in the required experience hours. The hours submitted must be appropriate.

Developing AQB Requirements.

There will be changes in the continuing education requirements, mandated by the Appraisal Foundation and in prelicensure requirements, to be added to the rules for fair housing and evaluation bias. This is a new AQB Requirement to begin January 2026. AQB has the requirements posted on their requirement page. All licensed appraisers will be required to take this class.

Freddie Mac and Fannie Mae, when they submit a complaint to a licensing board, it is a complaint that should be taken seriously. Freddie and Fannie complaints are reviewed in depth prior to submitting complaints to the board.

AARO has a meeting in October in Boston. Checking to see if there are any members who wish to attend. Matthew Kruse will attend if there is no one else who wishes to attend.
