

#### FUNDS SOURCES AND USES

#### Condition and Context

Upon retirement of the prior Library Director at December 31, 2017, the Library paid a portion of the Director's accrued leave time in the amount of \$100,617 from the Library Improvement Reserve fund.

#### Criteria

Indiana Code 36-12-3-11(a)(4) states:


"Money or securities may be accumulated in any library improvement reserve fund to anticipate necessary future capital expenditures, such as:

- (A) the purchase of land;
- (B) the purchase and construction of buildings or structures;
- (C) the construction of additions or improvements to existing structures;
- (D) the purchase of equipment; and
- (E) all repairs or replacement of buildings or equipment."

Sources and uses of funds must be limited to those authorized by the enabling law, ordinance/resolution, or grant agreement. (Accounting and Uniform Compliance Guidelines Manual for Libraries, Chapter 1)

Subject: Official Response to Audit

In December of 2017, the Director of the Aurora Public Library District submitted her resignation following an extended illness. During her 35-year term as Director, she had accrued a large amount of paid time off which was payable upon her retirement.

At the December 2017 meeting of the Aurora Public Library District Board of Trustees, the Director's resignation was accepted. Faced with the need to finance a considerable retirement package, the decision was made to use funds from both the Rainy Day Fund and the Library Improvement Reserve Fund (LIRF). Since establishing these two funds, the Board has kept the two funds approximately equal in value, and the decision was made in an effort to maintain that balance.

The Aurora Public Library District Library Board has been made aware that LIRF funds are designated for capital expenses and will work during 2020 to restore this money to the LIRF account.
