

ORDINANCE NO. 2017- 02

An Ordinance Amending Chapter 2 of Article 2 of the Advance Municipal Code Pertaining to Rates and Charges for Water Service for Customers of the Advance Municipal Water Utility of the Town of Advance, Indiana.

WHEREAS, the Town of Advance, Boone County, Indiana (the “Town”) previously adopted and codified in the Advance Municipal Code Article 2, Chapter 2 certain rates and charges for water service for customers of the Advance Municipal Water Utility and now wishes to modify the same rates and charges; and

WHEREAS, the Town also wishes to incorporate rates and charges for wastewater service for customers of the Advance Municipal Water Utility into the Advance Municipal Code Article 2, Chapter 2.

NOW, THEREFORE, BE IT ORDAINED, ORDERED, RESOLVED AND ESTABLISHED by the Town Council of the Town of Advance, Boone County, Indiana, as follows:

SECTION 1. Section 2-2-1 of the Advance Municipal Code is hereby amended to read as follows:

For customers both inside and outside the corporate limits of the Town of Advance, monthly water rates based on the number of gallons consumed per month shall apply as follows:

MONTHLY USAGE	RATE
First 2,000 gallons	\$18.50
Next 1,000 gallons	\$15.61
Next 7,000 gallons	\$12.42
Next 10,000 gallons	\$11.22
Next 30,000 gallons	\$8.79
Over 50,000 gallons	\$4.58

For customers both inside and outside the corporate limits of the Town of Advance, monthly minimum charges for water service based on meter size shall apply as follows:

METER SIZE	MINIMUM CHARGE
5/8-inch	\$37.00
3/4-inch	\$37.00
1-inch	\$66.35
1 1/2-inch	\$128.05
2-inch	\$157.45

For fire protection service, the following flat annual rates shall apply:

TYPE OF HYDRANT	RATE
Public	\$176.98
Private	\$176.98

SECTION 2. Section 2-2-2 of the Advance Municipal Code is hereby amended to read as follows:

For customers both inside and outside the corporate limits of the Town of Advance, monthly wastewater rates shall apply as follows:

TYPE OF RATE	RATE
Base Charge	
5/8-inch or 3/4-inch meter	\$41.05
1-inch meter	\$100.40
2-inch meter	\$392.65
3-inch meter	\$899.90
Flow Charge	
Per 1,000 gallons	\$4.20
Unmetered Users	\$64.50
Minimum Charge per Month	\$49.45

SECTION 3. Section 2-2-3 is hereby added to the Advance Municipal Code and shall read as follows:

Should water service to any customer be disconnected by the Town, either voluntarily or involuntarily, no minimum charges shall accrue on such customer's account during the period services are disconnected. The fee for reconnecting water service to any customer following a disconnection shall be \$50.00 and shall be due and payable prior to the reconnection being made.

SECTION 4. Section 2-2-4 is hereby added to the Advance Municipal Code and shall read as follows:


Should any customer who is a tenant relocate from one rented residence to another and leave any outstanding and unpaid balance that is due and payable on the water service account related to the customer's former residence, the Town may disconnect the water service related to the customer's new residence until such balance is paid in full.

SECTION 5. This ordinance shall be in full force and effect from and after its passage and approval according to law. This will take effect for February, 2017 use, billed March, 2017.

SECTION 6. This ordinance repeals all ordinances or parts of ordinances in direct conflict therewith.


