Upon application and payment of the applicable fee, a Resident of the Town of Beverly Shores may purchase up to two (2) books (sold separately) of Guest Parking Permits annually. Passes will expire the end of year of issue. These Permits shall be issued by the Clerk-Treasurer of Beverly Shores. The following restrictions and exclusions apply:

1. Guest Parking Permits are valid for day that is written on permit **ONLY**. Date must be written legibly in permanent ink.
2. Guest Parking Permits are valid for parking at Rebora Plaza **ONLY**.
3. Guest Parking Permits must display address of Beverly Shores Resident to be valid.
4. Guest Parking Permits must be displayed on the front dash board on the driver side of the vehicle.
5. Guest Parking Permits are not valid on **Memorial Day, July 4<sup>th</sup> or Labor Day**.
