ORDINANCE 2023-020

An Ordinance Revising, Amending and Restating the COMPREHENSIVE ZONING ORDINANCE of the Town of Culver, Indiana, and Contiguous Unincorporated Territory Under the Jurisdiction of the Culver Plan Commission, Containing Regulations, Requirements, and Providing for the Administration, Enforcement and Amendment Thereof

WHEREAS, the Town Council of Culver, Indiana, deems it necessary that the Zoning Ordinance of the Town of Culver, approved and passed as local ordinance 2010-007 and subsequent amendments be revised and amended; and

WHEREAS, I.C. 36-7-4-600 through I.C. 36-7-4-699, empowers the Town to enact a zoning ordinance and to provide for its administration, enforcement and amendment; and

WHEREAS, The Building Commissioner shall maintain a schedule of fees for all applications, permits, and other processes outlined in this Ordinance. The Building Commissioner shall review the fee schedule annually and bring any necessary revisions to the attention of the Plan Commission and Culver Town Council; All fees shall be intended to reimburse the Town of Culver for the time and cost of processing the required applications.

WHEREAS, the Plan Commission of Culver, Indiana has given reasonable consideration, among other things, to the current cost structure for Building Permit and Application fees and recommends the proposed new fee schedule; and

WHEREAS, the Plan Commission has made a preliminary report and held a public hearing thereon, and submitted its final report to the Town Council; and

WHEREAS, the Town Council has given due public notice of hearings related to the current cost structure for Culver Building Permit and Application Fees that are in addition to Marshall County Fees and has held such public hearings; and

WHEREAS, all requirements with regard to the preparation of the report of the Plan Commission and subsequent action of the Culver Town Council have been met;

NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of Culver, Indiana as follows:

<u>Section 1</u>. Schedule "B" to the Zoning Ordinance to the Town of Culver hereby is amended to read in its entirety as follows:
