ORDINANCE 2016-001 AN ORDINANCE TO AMEND THE PERMIT FEES BEING CHARGED FOR BUILDING PERMITS AND APPLICATION FEES

WHEREAS, the Culver Plan Commission has held a public hearing to consider changes to the Culver Zoning Ordinance, being Ordinance 2010-007, specifically with respect to making changes to Schedule "B" relating to permit fees; and

WHEREAS, said public hearing was held by the Culver Plan Commission on December 15 2015 regarding said changes after due notice to the public and the same was approved and recommended favorably by the Plan Commission on a vote of 6 to 0; and

WHEREAS, the Town Council has now held a public hearing on said proposed changes to said Schedule "B" and now wish to move forward with making said changes.

NOW, THEREFORE, BE IT ORDAINED BY THE CULVER TOWN COUNCIL AS FOLLOWS:

Section 1. Schedule "B" to the Zoning Ordinance to the Town of Culver be and the same hereby is amended to read in its entirety as follows:

- B. Any ancillary fees incurred as part of permit issuance such as legal, engineering, and/or survey fees are in addition to the above listed fees.
- C. Any person or agent in charge of such building or land who commences erection, construction, reconstruction, or alteration of said property without first obtaining an improvement location permit shall be automatically fined triple the fee normally charged for such permit.
- D. Any person or agent in charge of such building or land who violates, disobeys, omits, neglects or refuses to comply with any provisions of the Zoning Ordinance of Culver, Indiana or amendment thereof, shall be fined upon conviction, not more than \$100.00 for each day's violation plus cost of prosecution. Each and every day during which any illegal activity continues shall be deemed a separate offense.

Section 2. This Ordinance shall be in full force and effect from and after its passage and due attestation and publication as required by law.
