

ORDINANCE 2015-1-1

AN ORDINANCE OPENING NEW SECTIONS OF OAKLAND CEMETERY AND
AMENDING THE FEE SCHEDULE OF CHARGES FOR GRAVE LOTS

WHEREAS, the Town of Montezuma desires to expand Oakland Cemetery by opening Sections D, E, and F, pursuant to the plat attached hereto as Exhibit A.

WHEREAS, the Town of Montezuma further desires to amend the fee schedule of charges for grave lots and services.

NOW, THEREFORE, be it ORDAINED by the Montezuma Town Council that:

1. Sections D, E, and F in Oakland Cemetery are hereby opened pursuant to the plat attached hereto as Exhibit A.
2. The Montezuma Municipal Code is amended to read as follows:

MMC 7-1-7: CHARGES FOR GRAVE LOTS AND SERVICES

Sec. 7: The following charges shall apply for grave lots and services:

RESIDENTS AND/OR PROPERTY TAXPAYERS OF MONTEZUMA AND RESERVE TOWNSHIP

Section A	\$130 per grave
Section B	\$150 per grave
Section C	\$200 per grave
Section D	\$400 per grave
Section E	\$400 per grave
Section F	\$400 per grave
Complete 6 grave lot (Section C only)	\$1,000
Complete 6 grave lot (Sections D, E, or F)	\$2,000

ALL OTHERS

Section A	\$180 per grave
Section B	\$200 per grave
Section C	\$250 per grave
Section D	\$500 per grave
Section E	\$500 per grave
Section F	\$500 per grave

Complete 6 grave lot (Section C only)	\$1,250
Complete 6 grave lot (Sections D, E, or F)	\$2,500

For each grave lot purchased, \$50 from the purchase price shall be deposited in the Perpetual Care Fund. For the sale of a complete 6 grave lot, \$250 shall be deposited in the Perpetual Care Fund.

Grave Opening – Monday thru Saturday	\$300
Grave Opening – Sunday and Holiday	\$500
Grave Opening (infant) Monday thru Saturday	\$100
Grave Opening (infant) Sunday and Holiday	\$200
Burial of Cremated Remains Monday thru Saturday	\$100
Burial of Cremated Remains Sunday and Holiday	\$100
Foundations – Small (24" x 12" <i>32 x 20</i>)	\$100
Foundations – Large (48" x 12" <i>70 x 20</i>)	\$130
Foundations – VA	\$50
Chapel Rental	\$150

3. This Ordinance shall be effective upon its adoption.
