Robbins asks if there is anyone present with questions or comments. No one is. The public hearing is closed at 5:22 p.m.

Attorney Robbins introduces Ordinance 2020-03 to re-establish the maximum rate on first reading. Motion by Councilman Alspach to approve Ordinance 2020-03 and second is made by Councilman Vaughn. **Vote 4 affirmative.**

Councilman Schilawski moves to suspend the rules and hear the ordinance on final reading and is seconded by Councilman Vaughn. **Vote 4 affirmative.**

Council President Perrin reads the ordinance in title only on final reading. Motion to adopt by Councilman Vaughn with second by Councilman Alspach. **Vote 4 affirmative.**

OLD BUSINESS

Fire Engine Financing

Attorney Robbins explains that we were able to secure financing through the Indiana Bond Bank with U.S. Bancorp for a ten (10) year term with an interest rate of 2.02 %. This is a much better deal than what we previously presented. Robbins has prepared the Master Lease

Purchase Agreement for council approval along with Resolution 2020-05 authorizing the Master Lease Purchase Agreement. Attorney Robbins reads and explains the resolution. Councilman Alspach moves to adopt the resolution and approve the Master Lease Purchase Agreement and is seconded by Councilman Vaughn. **Vote 4 affirmative.**

Wastewater SRF Project

Council President Perrin states that he received notice this week that our project has been approved.

NEW BUSINESS

Johnson County Public Library Presentation

Clark Pleasant Branch Manager Davin Kolderup talks about services the library is offering during the shelter in place restrictions. The branch closed on March 16th. They began 7 day a week curbside pickup on May 4th. They are delivering books to high risk patrons. The summer reading program will take place June 1st thru July 31st with prizes this year going to not for profits. Davin shared news of the new branch that will open at the end of 2021 or early in 2022 depending on construction. The existing branch hopes to reopen this fall.

Clerk-Treasurer Report

Clerk-Treasurer Alspach states that she will getting 2021 budget packets out to the department heads within the next week. All indications are that we will need to cut any unnecessary expenses this year and our 2021 budget needs to be equal to or less that the 2020 budget due to lost revenues as a result of COVID-19.

Today was supposed to be the day we hosted the Circus; they will be contacting us with a new date for 2021.

We will begin transitioning over to Citizens Bank this month. We are waiting on our deposit tickets and stamps.

We have been tracking delinquent accounts for when the Governor's Executive Order is lifted and IAW begins doing disconnects again. As of today, we have 127 delinquent accounts.

Compliance Officer Bob Downey has begun shadowing the Bargersville Inspector and is excited to gain more knowledge and be able to help out with permits and inspections during the day and when Tim is unavailable.

Date to reopen the offices – tabled until June 2nd meeting.

Request from customer to be removed from cash only. M. Kleyn, 145 Crestwood is requesting removal from cash only status. He has made timely payments for more than a year. Council approves.
