Board agreed that Bruce should call the sheriffs dept if there are any problems with BB guns & 4 wheelers.

New Business

Keystone upgrade for the Utility program Jan quote was \$3495. Julia will call to see if the quote is still good. The installation couldn't be done until September. Well went down again due to an overload from Cinergy. Heaters are being made now to replace the ones in them now. Steve made the motion to purchase phase protectors to be installed by Kraig Barker for a total of \$500. Brady 2nd carried 3-0.

Cap for wall on aeration tank will cost \$275 for labor & parts. Cap being made by Schlemmer Brothers out of stainless steel for \$690. Brady made the motion to have the repairs done Steve 2nd, carried 3-0.

Backflow valve at plant on water line needs replaced, can not be recertified again. cost \$226.70 for new one & certified for one year. from KB backflow. Steve made the motion to have it replaced, Brady 2nd carried 3-0.

Steel tape cost 3/4" 200 ft \$242 & 1" 100 ft. \$272, Bruce to check for more prices.

Steve suggested getting the sandbox off the truck & have it sandblasted & repainted before next winter. Bruce to get quotes.

Town needs to purchase some kind of wagon or trailer to set the sandbox on for the summer so that it is portable. It weighs over 800 lbs. & takes up extra space in the town building.
