The regular monthly meeting was called to order on November 11, 2003 at 7:00 p.m. in the Town Hall by President Brady Brower, Steve Johnson, Daniel Yocum, Bruce Shaw, & Julia Rensberger were present. 17 residents were present.

*The cars that were tagged will be towed by Nov 19th. There are about 18 left. The towing service will send us a bill, then the town will put liens on property to recoup the charges for the towing service. The ordinance states the property owner will be charged the fees. The property owners with rentals will also be charged for the renters towed vehicles. A letter should be sent to the owner to make them aware there is a problem with a vehicle. Mike Chenault requested a 30 day extension on the notice for his tagged car. He is in the process of selling the car. Daniel made the motion to extend him 30 days, Steve 2nd carried 3-0. There was also a question on how long a car can be setting there before being tagged. The ordinance has no time limit. They can put the vehicle in a garage if there is no current license plate.


*Curfew is followed by the state guidelines.
