#### I. Call to order

- f) James Pell made a motion to approve the second reading of Special Ordinance No 1, 2020 of Utility Organization A. Jerry Nelson seconded and the Town Council voted in favor 3-0.
- g) Steve Hicks advised posts are in the ground and ready to hang the Speed Signs.

#### **New Business**

a) Robert "M" Ferguson Jr. stated he received a quote of \$11,640.00 on a Belt Receiver, 24 meters and software which links up with the IPhone. James Pell made a motion to

purchase the Belt Receiver, 24 meters and software package for \$11,640.00. Jerry Nelson seconded and the Town Council voted in favor 3-0.

b) Citizen Steve Johnson reported he is still having occasional rusty or discolored water. Bruce Shaw stated the phosphate will be added by the end of the year.
