## I. Call to order

- d) Robert "M" Ferguson Jr. reported Sam Knight from Gaunt and Son has dug and measured the two test holes in the alley behind the Town Hall from Allen Street to Walnut Street and will let us know on their recommendations.
- e) Kristina Lynn will follow up on the right of way at Adams Street and Chippewa Street.

#### **New Business**

- a) Keith Walters from Wabash County Multi-Hazard Mitigation Plan advised the plan requires to be updated every five years and every corporation in the county must sign a Community Resolution to be approved. Jerry Nelson made a motion to adopt the Wabash County Multi-Hazard Mitigation Plan Resolution No. 2, 2019. James Pell seconded and the Town Council voted in favor 2-0.
- b) Robert "M" Ferguson Jr. stated the Special Ordinance No. 1, 2020, is the Salary Ordinance for 2020. Jerry Nelson moved to approve the Special Ordinance No. 1, 2020, first reading. James Pell seconded and the Town Council voted in favor 2-0.

c) Tony Janeway presented a quote of \$4,700.00 for two moveable posts for the Speed Signs. After discussion, the Town Council decided to install permanent posts at this time to get the Speed Signs up.
