IV. Approval of Minutes from last meeting

The Town Council read the minutes from the Regular Board Meeting on August 10, 2021, the minutes were approved as read.

Open issues

- a) Robert "M" Ferguson Jr. stated Ordinance 2022-1 Budget 1st reading is ready for approval. James Pell moved to accept 1st reading Budget Ordinance 2022-1. Jerry Nelson seconded and the Town Council voted in favor 3-0. The Town Council Votes were as follows: Richard Morris AYE, James Pell AYE, Jerry Nelson AYE, approving the 1st Reading of 2022-1 Budget Ordinance.
- b) Richard Morris stated Ordinance No. 14-2021 Appropriation Reduction 1st Reading is ready for approval. - h) Robert "M" Ferguson Jr. reported Bunnell is working on surveying the area of the Retention Pond that belongs to Donald Long, James Pell made a motion to approve Bunnell Land Survey of \$7,175.00 for the Retention Pond area. Jerry Nelson seconded and the Town Council voted in favor 3-0.
- i) Robert "M" Ferguson Jr. presented the Employee Handbook 1st Reading to each of the Council Members, Kristina Lynn, Steve Hicks and Tony Janeway to review and make any suggestions at the next Regular Board Meeting.

- a) Tony Janeway and Bruce Shaw will be attending Fall Conference October 19 through 21, 2021, in Fort Wayne. Jerry Nelson made a motion to approve lodging, meals, and mileage. James Pell seconded and the Town Council voted in favor 3-0.
- b) Robert "M" Ferguson Jr. advised he will be attending AIM Conference October 5, 6, 7, in French Lick. The Town Council agreed to cover lodging, meals, and mileage expenses.

c) Resident Daniel Griffith of 525 East Pike Street stated he had not moved the bee hives. After much discussion, The Town Council agreed to give him until September 30, 2021, to have the beehives moved to comply with the Beekeeping Ordinance No. 13-2021. Marshall Steve Hicks reported Mr. Griffith had still not complied with the Weed and Rank Vegetation General Ordinance No. 9-2016. Clerk Treasurer Robert "M" Ferguson Jr. stated a Certified Letter had been sent for Violation of Weeds and Rank Vegetation on August 25, 2021, and the letter was signed by the resident on August 28, 2021. The Town Council agreed to give him through the weekend to comply with General Ordinance No. 9-2016 regarding weeds and rank vegetation. Marshall Steve Hicks will follow up on progress at 525 East Pike Street.
