I. Call to Order

III. Approval of Minutes from last meeting

Open issues

- a) Robert "M" Ferguson Jr. shared he met with Alex Downard, the Engineer and the Design Company for drawings on the Park Project for the Pavilion, Restroom, Water Shed, water and sewage and hope to have ready by first of October.
- b) The Council tabled the Burn Ordinance until the next board meeting.
- c) The Council tabled Parking Ordinance until the next board meeting.
- d) Tony Janeway reported Scott Hanes will do the electrical for the gas pump at the plant in the next few days.
- e) Jerry Nelson stated the Community Heritage Main Street Organization has reimbursed the Town of Roann in full for the sidewalks.

Robert "M" Ferguson Jr. stated Randel Construction will need to split the roof invoice for \$7,000.00 to come to the Town of Roann and the remainder going to the Lions Club.
- f) Pam Ford presented to the Town Council a copy of an insurance contract during festivals for the Town Council to review and/or change. Kristina Lynn will review.
