

WHEREAS, after careful investigation and consideration this Board deems it to be in the best interests of the Town of Roann, Indiana to annex to said Town certain platted territory contiguous to the present corporate boundaries.

NOW THEREFORE, BE IT RESOLVED that the following described territory shall henceforth be considered within the corporate limits and a part of the corporate Town of Roann, Indiana, to-wit:

Lots number one(1), three(3), five(5), seven(7), nine(9), eleven(11), thirteen(13), fifteen(15), seventeen(17), nineteen(19) and lots numbered twenty-one(21) through forty-four(44) inclusive all in Fairview Addition to the Town of Roann, Indiana, lots one(1) through nineteen (19) being twenty-five(25) feet wide and one hundred thirty-two(132) feet deep; lots twenty-one(21) through thirty-eight(38) being twenty-five feet and six inches(25.6) wide and one hundred thirty-two (132) feet deep; lots thirty-nine(39) through forty-four(44) being twenty-five(25) feet wide and one hundred thirty-two (132) feet deep.

Said addition consists of forty-four (44) lots in all being of such shape and dimensions, including streets and alleys as indicated on attached plot, marked " Exhibit A ". A discription of said addition is further attached hereto on said " Exhibit A ".
