- > Mr. Perez expected an announcement on Friday, October 6 on our CCMG application.
- ➤ Work at Urban Street and Main Street has begun as part of the SR22 project.
- > The Utility Department is looking into purchasing a mini excavator with excess Sewer SRF funds.
- > The Stempark Grand Opening was well attended by the community.

The Council did a performance review and set goals for 2024.
