Upland Town Manager, Jonathan Perez

- The Council was given copies of the agreement with Yardberry Landscape Company, Payment Bond and Certificate of Insurance. - ➤ Mr. Perez reported that the Jefferson Street Stormwater Project is on schedule and is scheduled for completion by October, 2023.
- > He gave an update on the WWTP project. This project is on schedule and under budget to date.
- ➤ We have received a quote to fix the timers on the lights at the park. That quote was more than \$3,000. We are getting additional quotes.
- > Brad Felver is working with RMA on the infrastructure for the loop for lots at 8th and Indiana Ave..
- ➤ Mr. Perez reported that he is working on getting a quote from RMA for the stormwater issue on Warkentin Court.
- ➤ Grant County Area Plan will be paying to demolish the old print shop. We may need to cover the cost of the dumpsters needed for this project. This will save the town \$50K+.
- ➤ He also reported that he will be at the AIM Conference April 26-28.

Public Comments:

- Andrew Preston, 230 S. Main Street
 - ➤ He has been going over the town ordinances that were posted online. He noticed many inconsistencies and things that need to be cleaned up and updated.
 - He has concerns about the Upland Farmers Market and whether they fall under the Transient Merchant Ordinance. Jonathan Perez addressed this concern by stating that he is working with the owner of the farmer's market and addressing this question. Councilman Voss said he will bring this issue up at the next Park Board meeting.
- Dr. Beulah Baker- 651 W. Warkentin Court
 - ➤ Dr. Baker expressed her concern about the drainage issue on Warkentin Court. Water is being drained into the street, right in front of her mailbox and driveway. She will be monitoring the progress of addressing this issue.
