  - o 4% increase for all other staff
  - The EMS and Fire Fighter staff increases is an exceptional occurrence for the 2024 proposed budget.

 Trustee Holliday impressed upon the Fire Fighter representatives that future salary negotiations be conducted with the Chief and Trustee, and not each board member.
